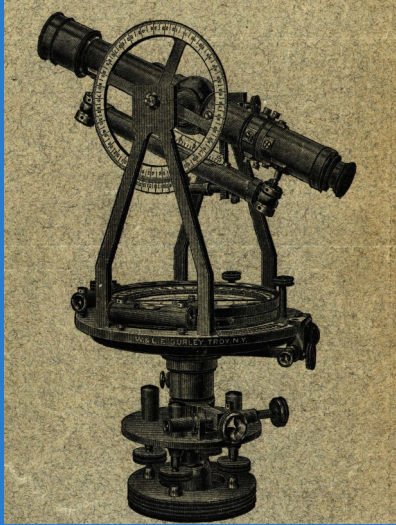

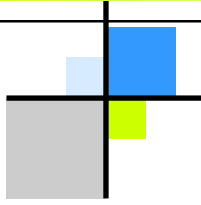

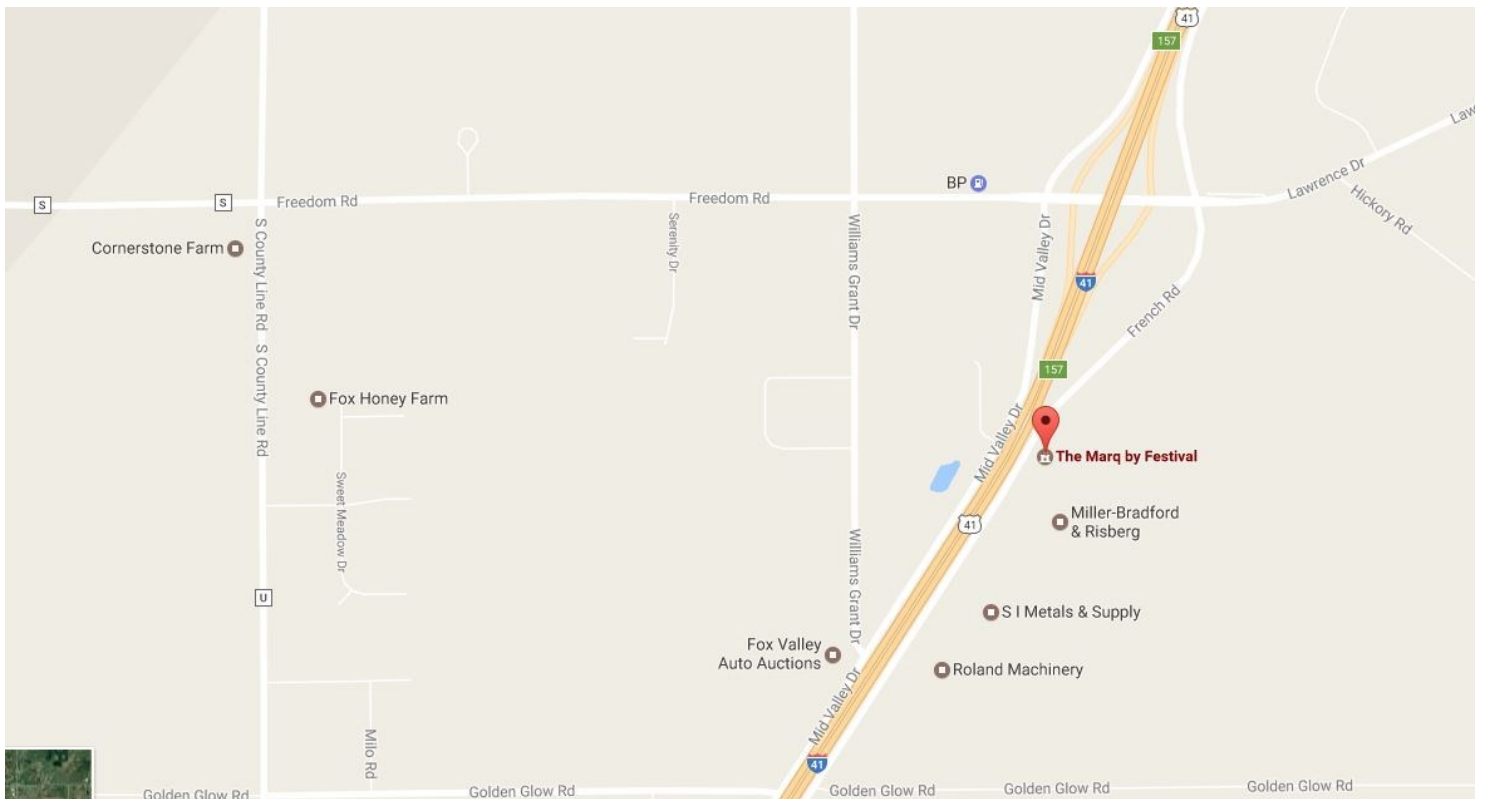

2016 FALL GENERAL MEETING MINUTES

October 13, 2016 – Liberty Hall in Kimberly, WI

The 2016 Fall General Meeting was held on October 13, 2016 at Liberty Hall in Kimberly, WI. There were 62 members present when Chapter President Aaron Ballast introduced:

Presentation

Several NWTC Civil Engineering Technology Club members presented their experiences while participating in the Public Land Survey System (GLO) Workshop in the Sylvania Wilderness Area in Upper Michigan this past summer. The area is quite large and is considered to be primarily untouched by humans. It is also unlogged. Many original government corners are still waiting to be found (approx 20%), so Zac Hoshner, Zach Solberg, Joe Massie, Joseph Robinson and Glody Orny decided that they wanted to be a part of the whole experience. The Civil Engineering Club paid for the trip.

Pat Leeman was the presenter, also giving a short seminar on the local monument history and a quick update on the trip ahead for the students. The students described the beautiful wilderness area, walking way more than a “couple miles”, discovering blazed trees, finding meander corners, setting rebar, scribing trees and more

All students agreed that the trip was way worth the experience and would do it again.

President Ballast thanked all the NWTC students for presenting their thoughts and experiences during their GLO Workshop trip. He then called the General Meeting to order at 8:35 pm

- Frank Thousand needs all 2017 Chapter Rep names by December 1
- Possible elimination or reduction of auditing CE by Licensing Board – new budget, still under discussion
- Lisa Van Horn is running for Vice President of NSPS. Voting is online from Dec. 1 thru Dec. 31 VOTE!
- Phil Peterson estate donated \$100,000 to Foundation
- Nominations for WSLs officers available until Dec. 1
- New SurveyMonkey coming out soon for follow up questions regarding election process
- New copy of “Wisconsin Laws” is being developed with lots of changes. Printed copies or online??
- Central Chapter is setting a monument near 90° 45’, a place where ginseng is abundant and a better potency. “Four Corners of the Earth” – only two of the places are on land: Wisconsin and China

NSPS Report (Lisa Van Horn)

- NGS has speakers available to go anywhere and discuss the upcoming 2022 adjustment
- NSPS is getting more involved with high schools students by creating several fliers aimed at showing students what surveying is all about, history, science, technology – everything that hopefully gets high school students interested in the surveying profession
- NSPS has an updated list of ALL schools offering survey related degrees – available online?
- California now requires anyone renewing their professional surveying license must take a test to make sure they are up on all the latest changes and updates to the laws
- Young Surveyors Group is getting more involved in NSPS. Being licensed is NOT required, must be under 35 years old or in school within the last 10 years

Ethics and Practices (Tom Leslie)

- One request for forms was received but then did not want to file with committee
- Brown County has been finding County washers with another PK nail driven thru the washer – really??

- Some Town officials have been complaining about surveyors breaking thru new chip seal to get to monuments. Brown County sends out requests for upcoming road projects. That way the department can tie off the corners in peril, and then get the monuments to the top of the chip seal once it's been applied. No breaking up the new surface needed – the Towns just need to let the County know which roads are involved

Land Records (Ryan Duckart)

▪ **NGS Restructure**

NGS has ended the State Advisor Program. As of October 1, 2016 John Ellingson has become a Regional Advisor. He will no longer have an office at WisDOT and members should contact him using his NGS email at john.ellingson@noaa.gov or phone 202-306-6904

▪ **Affidavit of Interruption; Adverse Possession and Prescriptive Use**

Recently a bill was passed as Wisconsin State Statute 893.305 allowing a record title holder to interrupt adverse possession of real estate and adverse use of real estate by recording a document at the register of deeds along with a survey of the record title holder's parcel that was certified no earlier than 5 years before the date of recording. The affidavit of interruption must include at least the following:

1. A legal description of the parcel of land that contains the real estate that is being adversely possessed or adversely used
2. A statement that the person executing the affidavit is the record title holder of the parcel
3. A general description of the adverse possession or adverse use that the record title holder intends to interrupt by recording the affidavit
4. A statement that the adverse possession or adverse use of real estate is interrupted and that a new period of adverse possession or adverse use may begin the day after the affidavit is recorded
5. A statement that the record title holder will provide notice

Notice of the record title holder's intent to record a notice of the affidavit of interruption on the neighbor's real estate that abuts the record title holder's parcel must be sent within 90 days of the date the notice is received. If the person who is adversely possessing or adversely using the record title holder's real estate is unknown to the record title holder at the time the affidavit of interruption is recorded, the record title holder shall provide notice by publishing a class 1 notice under chapter 985 in the official

newspaper of the county in which the record title holder recorded the affidavit of interruption

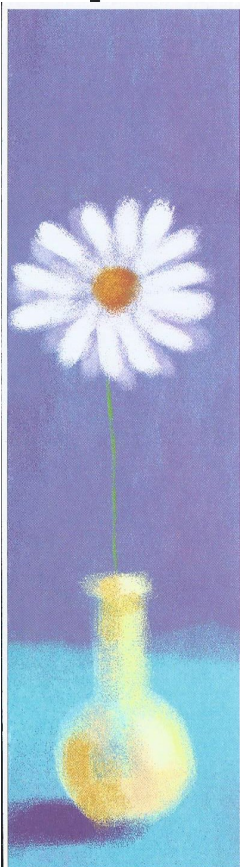

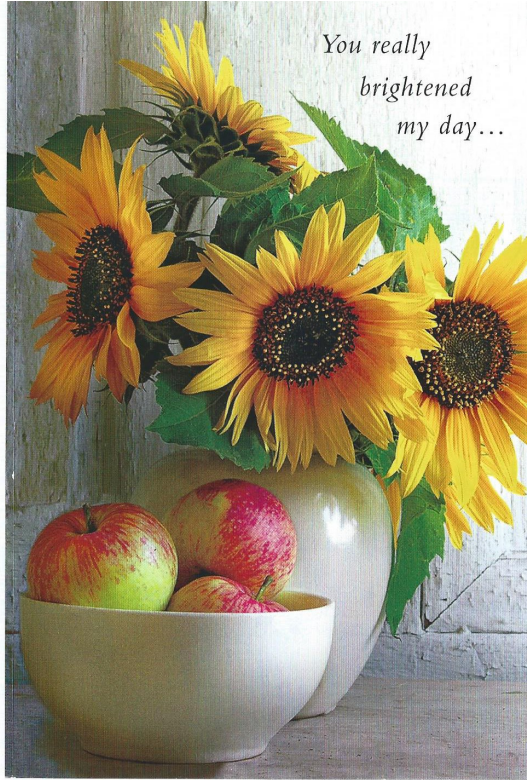
