Jeffrey "Kip" Inman

1954 - 2020

Jeffre y Kip Inman, 65, of Green Bay, WI, passed away on Thursday, August 27, 2020 after suffering a heart attack in his beloved lake house on Indian Lake in Manistique, Michigan.

Kip was born in Bloomington, Indiana on September 23, 1954, on his father's birthday to the late Earl Jeffrey and Marjorie Inman. Kip's family moved to Valparaiso, IN, where he spent his childhood, and later to West Lafayette, IN, where he attended junior high and high school at Harrison. In 1965, Kip assisted his dad in the construction of an A-frame cabin on Indian Lake in Manistique. By 1966, the family was spending every summer up north, and by age fourteen, Kip had saved up enough money to buy a gold hydroplane boat. Kip enjoyed a childhood with two younger brothers, Steve and Dan. Although the family took various vacations around the country during Kip's youth, Indian Lake became Kip's favorite spot because he had met and fallen in love with Lori White during his sophomore year of high school. After graduating from high school, Kip enrolled at Purdue University's School of Engineering and pledged Theta Chi fratemity. Kip couldn't bear parting with the love of his life every fall as she was in Michigan and he was in Indiana, and so he took a semester off from school to be with Lori and work in Michigan. He lived at Lori's parents' house with her whole family, and Lori's four younger siblings remember this time with Kip fondly. In March 1976, Kip and Lori were married, hone ymooned in Florida, and moved into married student apartments on campus. Kip graduated in 1977 with a Bachelor's Degree and began what would be a very accomplished career in land surveying. Kip would go on to perform many highway and bridge projects and then mastered construction layout; his most notable projects include hospitals, schools, Soldier Field in Chicago, IL, the Resch Center in Green Bay, WI, and Lambeau Field Packer Stadium.

After college, Kip and Lori moved to Mount Pleasant, MI and started a family. In 2011, Kip started a land surveying business with his sons. He was a skilled surveyor and generous husband, father, and grandfather. He will be dearly missed for the way he loved others so well, his sense of humor, his steadfastness, and his sensibility, among many other irreplaceable qualities.

Mark is also survived by 2 brothers, a sister, brothers and sisters-in-law, many nieces, nephews, aunts, uncle, and cousins. He leaves behind many dear friends and colleagues. He is preceded in death by his parents and a brother.

We will remember Mark as a kind and friendly man, who loved life's adventures but mostly he will be remembered as Dad, Papa, brother and friend. Mark recorded these words before his disability occurred and wanted them included in his obituary:

I want all who read this to know that there is absolutely no doubt in my mind that upon death I will enter heaven. I will do so, not by my own worthiness, but only through the merits of Jesus Christ, my Savior, who paid the price for my soul's redemption through his death on the cross. For me to live was Christ, and to die is gain. I commend my loved ones into the hands of the Lord and encourage them to place their faith and trust in him alone for their salvation.

I pray that the Lord would guard and protect my children. You are very special to me and I thank the Lord for you. Through your baptism you have been received into God's family and I urge you to remain faithful to Christ until you are called home to be with the Lord. I love you and I look forward to eternity with you in heaven.

Service: A private service will be held at First Lutheran Church. A Celebration of Mark's life will be held at a future time. In lieu of flowers, contributions in Mark's honor can be made to the Wisconsin Society of Land Surveyors Foundation to be used for student scholarships.

SPECIAL PRESENTATION

- Dick Kleinmann, PLS is the Project Manager Geospatial Division of Ayres Associates. He is Chair of WSLS Geospatial Committee, Co-Chair of Wisconsin Spatial Reference System 2022 Task Force (WSRS 2022) and Directors on WLS & NSPS Boards This presentation is not about technical issues but more about ramifications and implementation issues. Discussion included:
 - New datums are coming! Both horizontal reference frame and vertical datum, including a new geoid as well
 - There will be four terrestrial reference frames: North American, Pacific, Mariana & Caribbean
 - Approximately 1.25 meter shift in horizontal (ellipsoid center shift)
 - Elevation change for Wisconsin is approximately between -0.50 to -0.75 meters
 - No more negative longitudes all will be positive & East
 - Wisconsin will move forward from three zones to only two – no more State Plane coordinates (for now anyway)
 - ▶ US Foot being phased out on Dec. 31, 2022
 - ➤ Modernized NSRS planned for 2022 will be
 - delayed to 2024-2025 timeframe
 - \succ As professional land surveyors, we can
 - a. Build our base knowledge and gain a better understanding of the issues
 - Position ourselves to be the industry experts that our clients can count on to address these issues
 - c. Start making small changes in the way we do things now
 - d. Inventory your data, workflows and software to identify weaknesses
 - e. Complete GPS observations to add to and improve NGS data and conversion tools
 - Dr. Vonderohe is the person who led the redesign of the Wisconsin County Coordinate Systems back in 2006

- Administer the exam, and immediately score them
- Contact the winners and schedule a time to present them with the award money and certificates
- Submit test results to the WSLS Trig*Star representative and to NSPS




