Trig-Star

Trig-Star is just about wrapped up for the year. A total of 4 schools participated with over 100 students attending outdoor presentations that consisted of a brief description of land surveying and how we use math in our profession. We showed the students how to use a GPS unit and a Robotic Total Station to measure distances and then figured out the height of some structures using the Pythagorean theorem. The high schools within the Northeast Chapter that participated were Bay Port, Two Rivers, Denmark, and Luxemburg-Casco with 44 students taking the Trig-Star exam. 
