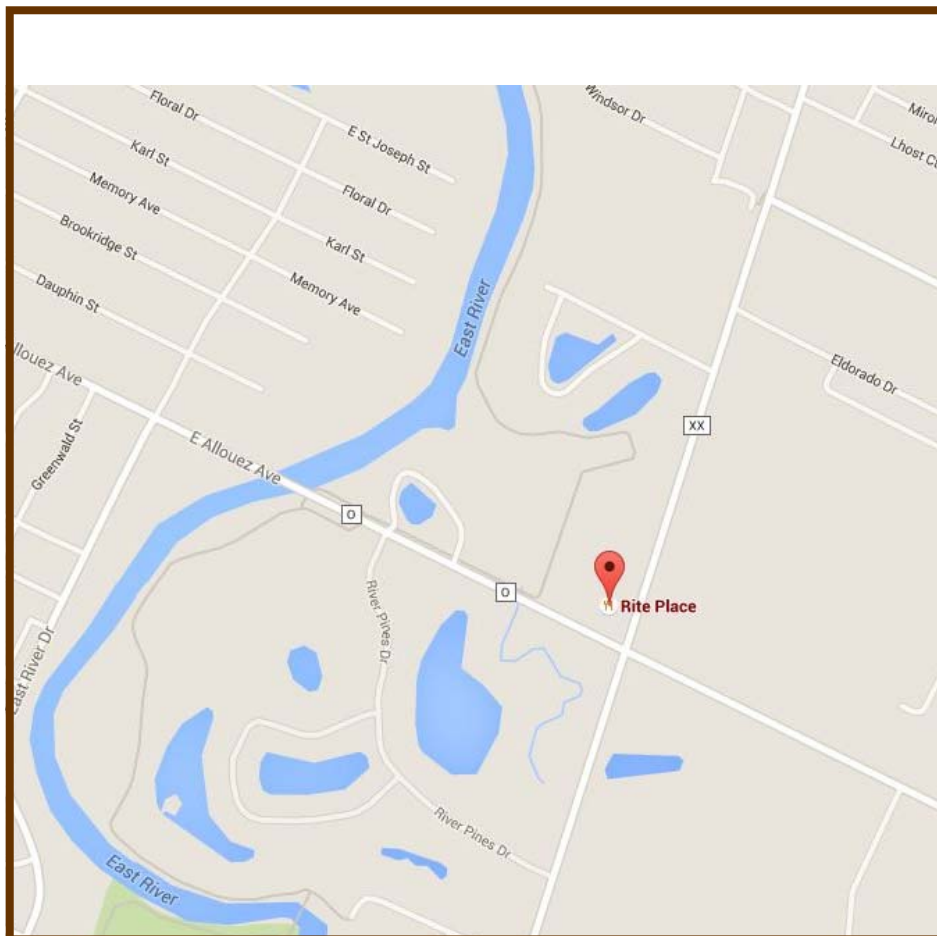

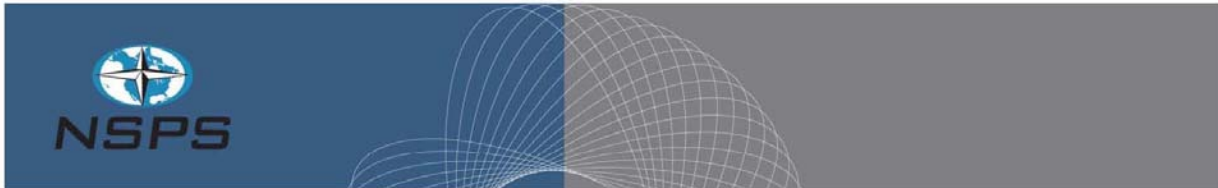

WisDOT is also fixing about 40 monuments across the state due to issues of soil erosion and/or vegetation

#### • IGLD Redefinition

NGS has initiated a geodetic (precise positioning) survey of the Great Lakes to update the vertical reference frame (the reference system for elevation). The survey will monitor elevation changes across the Great Lakes to facilitate the development of the International Great Lakes Datum 2020 (IGLD 2020), to be released in 2025. Similar surveys were conducted in 1997, 2005, and 2010. Movement of Earth's crust due to postglacial land uplift requires revision of the vertical datum used to define water levels in the Great Lakes-St. Lawrence River system every 25-30 years

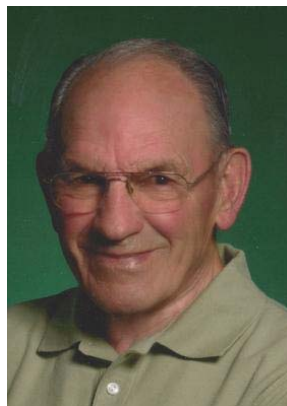
