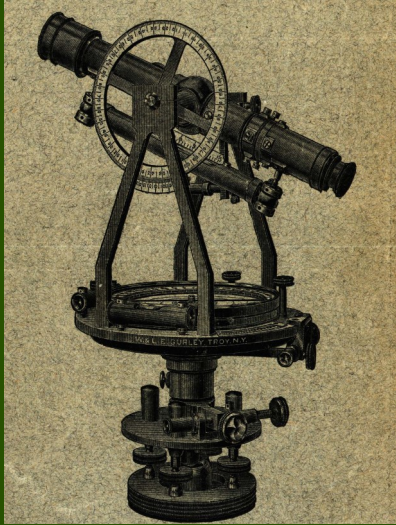

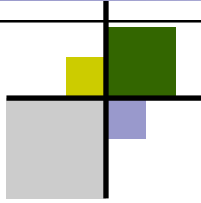

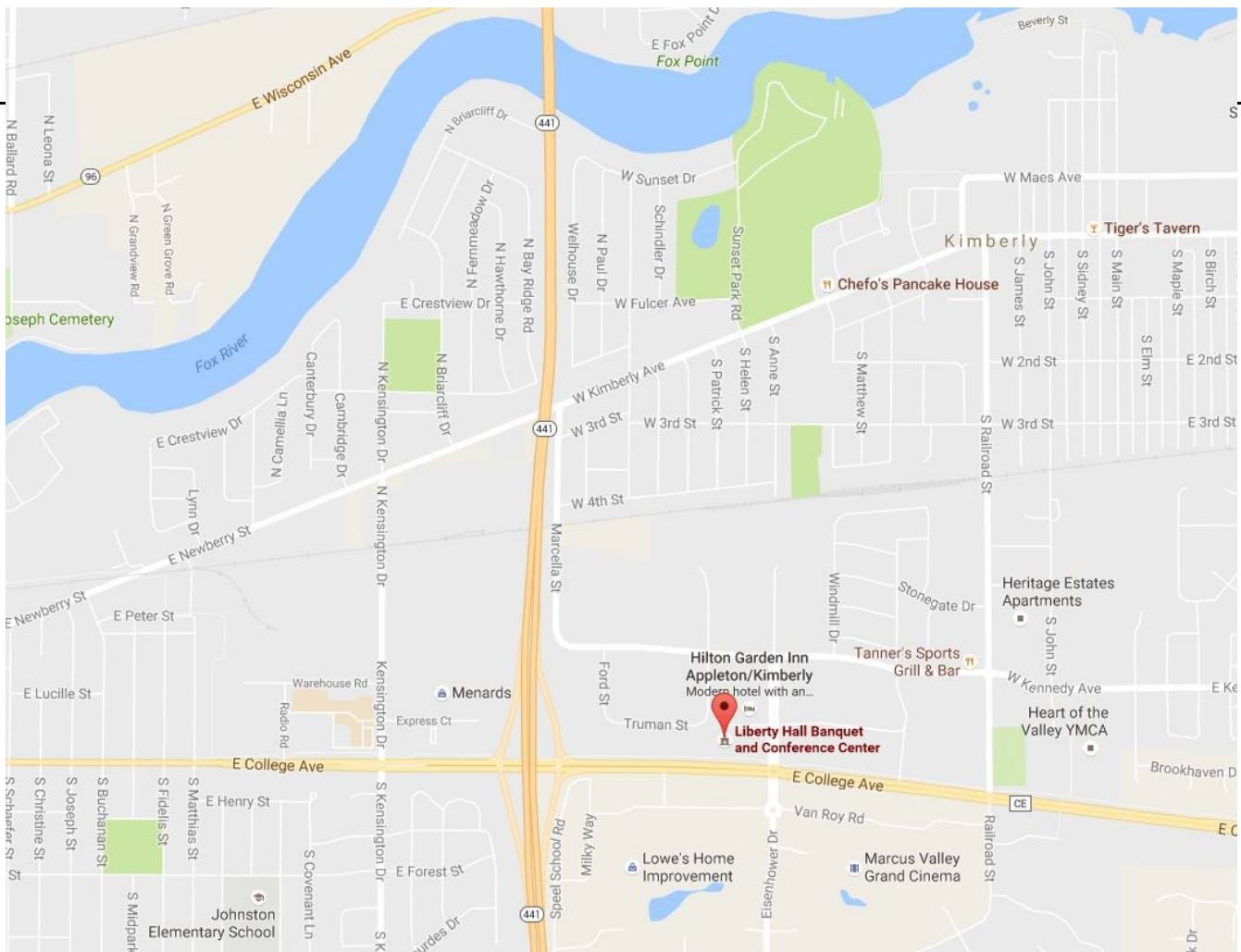

July 21, 2016 – Winagamie Golf Club in Neenah, WI

#### Special Presentation

President Ballast proudly introduced the arrival of former Oconto County Surveyor Mark Teuteberg and his wife Bonnie to the meeting. They made the trip to Neenah to pay a visit to all their fellow surveyors and friends who were in attendance.

Mark has a difficult time getting around by himself, but that did not stop him from having a BIG smile on his face during the whole time he and Bonnie were there.

Emily Pierce, current WSLs President, was also in attendance and presented Mark with a WSLs Lifetime Membership and plaque, thanking him for all his hard work and dedication to WSLs and the surveying profession.

Dave Chrouser then presented Mark with a Northeast Chapter Lifetime Membership and plaque. Dave spoke of the relationships Mark has made over the many years of working in the Northeast Wisconsin and the many accomplishments he has achieved through his involvement with all the various organizations (WSLS, WLIA, County Surveyors Association to name a few).

Mark, through his wife Bonnie, thanked both WSLs and the Northeast Chapter for all their continued support and words of encouragement during their Mark's unfortunate battle with West Nile disease.

Mark received a well-deserved standing ovation from everyone in attendance.

#### Presentation

Terry Van Hout, County Surveyor for Brown County, presented "Casco Junction: Rails to Trails", based on a past surveying job in Manitowoc County while owner of his own surveying company.

Terry discussed the challenges of surveying an area where two railroads converged, and the related ownership of his client. Making it more difficult was that fact that one railroad had a curved section going into the other; and discovering exactly what were the widths of these corridors. He also discussed how using physical evidence of old railroad beds,

remnant rails lying under existing pavement and aerial photography helped in determining where these corridors were located.

Rob Harris presented all the golf and trap results from earlier in the day. The weather was very warm but everyone enjoyed their time golfing and shooting clays. Prizes were given in both sports for best (and worst) scores, eventually giving a prize to everyone in attendance. ▪ **OUTAGAMIE COUNTY PLSS CORNER MAINTENANCE**

Recently letters were sent to the Outagamie County Board by the Wisconsin County Surveyors Association (WCSA), the Wisconsin Society of Land Surveyors (WSLS), Brown County and various surveyors to explain the importance of preserving the Government Corners. The County Board is looking to save money by no longer funding the maintenance of corners. They believed that since they have coordinates on all the corners that the coordinates could be used in place of monuments

**UAS REGULATIONS FOR COMMERCIAL SURVEYING**

The final rules have been released by the Federal Aviation Administration and information and resources are available to surveyors interested in using unmanned aircraft systems (UAS). Commercial use of small unmanned aircraft systems (sUAS) for operations within visual line of sight using a "drone" of less than 55 pounds take effect under new rules, which takes effect in late August (60 days from its June 28 official publication in the Federal Register). The regulations govern unmanned aircraft for commercial (non-hobby) operations, during daylight, up to an altitude of 400 feet, at up to 100 mph, and only over persons directly participating in the UAS operation. A remote pilot certificate is required, based on a knowledge test and security review. The FAA will make an online portal available in the coming weeks to apply for certain permitted waivers. Aerial surveying, mapping and photography are prominently mentioned in the FAA

rule, as are the comments submitted by geospatial organizations such as NSPS and MAPPs

**WLIP PROGRAM PLAN – DRAFT 3**

The Wisconsin Land Information Council (WLIC) met on June 8, 2016 to discuss Draft 2. In response to motions passed at the June and March meetings, public comments received on Draft 1 and Draft 2, and additional research and planning conducted by WLIP staff, DOA made several revisions.

The key changes are included in Chapters 1 and 4:

- A new overview and introduction on the planning process were added
- The county Strategic Initiative grant funding benchmark hierarchy was changed. Benchmark Set I remains parcels, followed by Set II for open data, and a Set III menu of options
- Set III allows counties to choose from options that include PLSS, aerial imagery, lidar and other Foundational Element layers to be determined
- The concept of a portal was put into the scope of the plan
- Draft 3 emphasizes that much more detailed work will be needed to be completed in the upcoming year to define additional benchmark standards, and invites public participation in the authorship of benchmark standards

DOA will look to continue to collaborate with the WLIC and land information stakeholders on further planning and implementation tasks. Any stakeholder group or any person with comments may send them to me at [ddittmar@waukeshacounty.gov](mailto:ddittmar@waukeshacounty.gov). **Comments are due by July 22nd**, and will be discussed at the next WLIC meeting, scheduled for August 1st.

## 2016 SUMMER BOARD OF DIRECTORS MEETING

August 11, 2016 – Mackinaw's in Green Bay, WI

There were 9 members present when President Aaron Ballast called the meeting to order at 6:29 pm

A motion was *made, seconded and approved* to accept the Board meeting minutes from May 12, 2016

Treasurer's Report was accepted as verbally presented. The Chapter funds are in good shape

### NEWSLETTER EDITOR REPORT (Jill Bostedt)\*

### WSLS REPORT (Rick VanGoethem)

- Much discussion on the current WSLs Election Process, including discussion on the latest Survey Monkey results and alternatives for the current process. Another survey may follow with more questions for the membership

### ETHICS AND PRACTICE (Tom Leslie)

### LAND RECORDS (Ryan Duckart)\*

- **AFFIDAVIT OF INTERRUPTION; ADVERSE POSSESSION & PRESCRIPTIVE USE**

Recently a bill was passed as Wisconsin State Statute 893.305 allowing a record title holder to interrupt adverse possession of real estate and adverse use of real estate by recording a document at the register of deeds along with a survey of the record title holder's parcel that was certified no earlier than 5 years before the date of recording. The affidavit of interruption must include at least the following:

- A legal description of the parcel of land that contains the real estate that is being adversely possessed or adversely used
- A statement that the person executing the affidavit is the record title holder of the parcel
- A general description of the adverse possession or adverse use that the record title holder intends to interrupt by recording the affidavit
- A statement that the adverse possession or adverse use of real estate is interrupted and that a new period of adverse possession or adverse use may begin the day after the affidavit is recorded
- A statement that the record title holder will provide notice

Notice of the record title holder's intent to record a notice of the affidavit of interruption on the neighbor's real estate that abuts the record title holder's parcel must be sent within 90 days of the date the notice is received. If the person who is adversely possessing or adversely using the record title holder's real estate is unknown to the record title holder at the time the affidavit of interruption is recorded, the record title holder shall provide notice by publishing a class 1 notice under chapter 985 in the official newspaper of the county in which the record title holder recorded the affidavit of interruption

# CONSTITUTION

## Northeast Wisconsin Chapter of the Wisconsin Society of Land Surveyors

(Last revised December 2011)

- Article I** The name of this organization shall be the Northeast Wisconsin Chapter of the Wisconsin Society of Land Surveyors
- Article II** The purpose of this organization shall be to promote the common good and welfare of its members in their activities in the profession of land surveying; to foster higher standards of professional ethics and practices; to encourage the continuous study of land surveying; to advocate and support the education of land surveyors; and to promote public faith and confidence in the reliability of land surveyors and their work
- Article III** This organization, its activities and membership shall be non-political, non-partisan, non-discriminatory and non-sectarian, in affiliation as a recognized regional chapter of the Wisconsin Society of Land Surveyors
- Article IV** Membership in the Chapter shall be of five grades: *Professional, Affiliate, Life, Sustaining and Student*
1. Any person who is registered as a Professional Land Surveyor in the State of Wisconsin shall be eligible to apply for membership as a PROFESSIONAL MEMBER. Newly Registered Land Surveyors residing within the Northeast Chapter shall be eligible for a one year free membership in the Northeast Chapter the year following registration. Professional members shall have full office holding and voting privileges
  2. Any non-registered person having an interest in the advancement of, or service to the Land Surveying Profession, shall be eligible to apply for membership as an AFFILIATE MEMBER. Affiliate members shall have no office holding or voting privileges, but may actively participate and assist in the management of chapter matters and committee assignments, except as committee chairperson
  3. Any person having reached the age of 65, or retired from active practice, having been a member for the two years prior to the date of retirement, shall be eligible for the membership as a LIFE MEMBER. Life Members shall have full office holding and voting privileges
  4. Any commercial or professional institution or individual interested or engaged in surveying or the manufacture of the instruments, equipment or supplies for the land surveying profession shall be eligible to apply for membership herein as a SUSTAINING MEMBER



5. Any person pursuing a course of study on a full time basis leading to a career in the profession of Land Surveying shall be eligible to apply for membership as a STUDENT MEMBER

**Article V** The Chapter Board of Directors shall consist of the *President, President-Elect, Immediate Past President, Secretary-Treasurer and one (1) Director*. The Professional and Life Members as provided in the By-laws of the Chapter shall elect the Officers of the Chapter. No two elective offices may be held by one person at the same time. The term of the Office of the President and President-Elect shall be one (1) year, with the current President-Elect becoming President the year after the President's final term. The term of the Office of Secretary Treasurer shall be one (1) year, but the incumbent may be elected to any number of successive terms. The term of Director shall be limited to one (1) successive term in the same office. The members of the Board of Directors may appoint a Professional or Life Member as an officer, by unanimous approval, for any Board of Directors vacancies

**Article VI** The Chapter Constitution shall be amended by the following procedure: A proposed amendment must be a signed, written petition submitted by a Professional Member or a Life Member to the Secretary-Treasurer to initiate an amendment. Within 30 days after Board of Directors approval of such amendment, the Secretary-Treasurer shall submit the proposed amendment to the Professional and Life Membership by U.S. mail or Electronic Mail (email) ballot. Sealed ballot vote shall be returned by U.S. mail or Electronic Mail (email) to the Secretary-Treasurer within 10 days of receipt. The ballots shall be counted, within 45 days after the mailing date, by a committee consisting of the President, Secretary-Treasurer and one signer of the petition as selected by the President. If two-thirds (2/3) of the ballot votes received are affirmative, the amendment shall be adopted. The Secretary-Treasurer shall notify the Board of Directors within 10 days, and publish the results in the following newsletter

**Article VII** There shall be By-Laws which shall govern the procedures for conducting the affairs of the Chapter. Changes in, or additions to these By-laws may be made at any time by an affirmative vote of two-thirds (2/3) of the Professional and Life Members of the Chapter who participate in a ballot or voice vote at a General Membership meeting



**BY-LAWS**  
**NORTHEAST WISCONSIN CHAPTER**  
**OF THE**  
**WISCONSIN SOCIETY OF LAND SURVEYORS**  
(Last revised December 2011)

**This Chapter shall function in accordance with the following by-laws:**

**Section I**      **Duties of the Officers**

The President shall preside at all meetings of the General Membership and of the Board of Directors. The President shall be the principal officer of the Chapter and guide its functions. He or she shall advise the Secretary-Treasurer of any verbal official acts or other actions that may be performed by this office, which may involve the Chapter and its members. A copy of all correspondence, during the President's term of office, shall be delivered to the Secretary-Treasurer for recording as part of the permanent record of the Chapter. The President-Elect will assist the President, and will act in the absence or by the direction of the President. In case of vacancy in the office of President, the President-Elect shall discharge the duties of the President until the next regular election. The Secretary-Treasurer shall be the custodian of the records, books, and financial matters of the Chapter. The Secretary-Treasurer shall conduct the official correspondence of the Chapter under the direction of the Board of Directors or any elected Chapter Officer. The Secretary-Treasurer shall prepare reports of all meetings of the Chapter or its Board of Directors, and perform such other duties as the Board of Directors may determine. The Secretary-Treasurer shall maintain an account of all receipts and expenditures of the Chapter funds and render financial statements as directed by the Board of Directors. The Secretary-Treasurer or Newsletter Editor shall prepare and publish a newsletter report to the Chapter Membership quarterly on affairs of the Chapter and related items of interest to the profession of land surveying. A copy of the newsletter shall be sent to each member and the Executive Director of the Wisconsin Society of Land Surveyors by U.S. Mail or Electronic Mail (email) at least 10 days before each General Membership meeting. Names of elected Chapter Officers and membership shall be forwarded to each Chapter Officer and the Executive Director of the Wisconsin Society of Land Surveyors within 10 days of the election of Chapter Officers. The Board of Directors shall have the option to appoint a Newsletter Editor who shall assume the responsibility of preparing and distributing the newsletter. The Immediate Past-President and the Director shall assist the President, President-Elect and the Secretary-Treasurer in the conduct of Chapter affairs. All Board of Directors shall provide the Secretary-Treasurer a copy of all correspondence they may conduct during their term of office, which concerns Chapter matters



**Section II Board of Directors**

The Board of Directors shall have vested in them the government of the Chapter, control of its property, and the direction of its activities. The Board of Directors shall consist of all elected officers of the Chapter. At the expiration of the President's term, this office holder shall be the Immediate Past President. The Board of Directors shall adopt rules for the conduct of business and activities of the Chapter and shall have the power to fill any vacancy on the Board of Directors. The Board of Directors shall review all applications for membership in the Chapter, and no membership application will be approved without the majority of the Board of Directors. The Board of Directors shall meet a minimum of once quarterly, and at other periodic time intervals deemed necessary by the Board of Directors in the interest of the Chapter. The Board of Directors may establish a salary for the Secretary-Treasurer and Newsletter Editors they deem equitable and necessary

**Section III Committees**

The mandatory standing committees are: Auditing and Nominating. The President shall appoint all Chapter committees and their Chairpersons and instruct them in their duties. The Board of Directors shall approve appointed committees. An appointed committee shall function and make its report to the Board of Directors and/or to the General Membership, as directed by the President. Each committee shall submit a written annual report to the Board of Directors. The report shall consist of a committee's actions during the past year. The Secretary-Treasurer will permanently record such writings in the Chapter records

**Section IV Meetings**

The Board of Directors shall schedule regular and special meetings of the General Membership or the Board of Directors. A regular General Membership meeting, to be known as the Annual Meeting, shall be held each year in January, prior to the Wisconsin Society of Land Surveyors Institute, and shall be for the primary purpose of electing officers. Other General Membership meetings shall be held in April, July and October. The Secretary-Treasurer shall send notices to each member at least ten days prior to the date of any General Membership meeting, giving the time, place and purposes of the meeting. The notice of the Annual Meeting shall include the names of the candidates for offices. At the Annual Meeting, elections shall be conducted, fiscal reports and President's report given, and other business as might be included on the agenda. Every member shall be entitled to speak twice, for a length of time deemed reasonable by the presiding officer, on any subject or question coming before the meeting. Members may not vote if dues are delinquent. Robert's Rules of Order, latest edition, shall govern all meetings

**Section V**    **Elections**

A President-Elect, Secretary-Treasurer and one Director shall be elected at the Annual Meeting to serve a one- (1) year term. In addition to those nominated by the nominating committee, nominations for the office may be made by Professional or Life Members from the floor during such meeting. After nominations are closed, the Professional and Life Members will proceed to elect the officers nominated by ballot or proxy vote. No Chapter officer shall be elected to office without a vote of the majority of the total paid Professional or Life Members present or their proxies. The Secretary-Treasurer and a Professional or Life Member not nominated for office will tally ballots. The Secretary-Treasurer will notify all paid Professional and Life Members of the results in the following newsletter. The officer's term shall expire at the annual meeting and the newly elected officers shall assume their duties under new business

**Section VI**    **Dues**

Dues for membership shall be annual and payable on or before the Annual Meeting. New members who apply for membership before July 1 must remit 100% of the annual dues. New members who apply for membership on or after July 1 must remit 50% of the annual dues. Annual dues for a Professional Member shall be at 100%. Annual dues for an Affiliate Member shall be at 50%. Annual dues for a Sustaining Member shall be at 200%. Annual dues for Life Members shall be at no charge. Annual dues for a Student Member shall be at 25%. Newly registered surveyors who reside within the Northeast Chapter shall be offered free membership until the second January 1st following their registration. The Board of Directors may recommend changes in dues which shall become effective after a majority vote of the Professional and Life Members present and proxies at the General Membership meeting. New dues shall be effective on January 1st of the year following year of adoption. Dues paid shall not be refunded to member upon their suspension of membership. The Secretary-Treasurer may provide each member with a membership card upon payment of dues as evidence thereof. Each new member may be provided with a membership card, a copy of the Chapter Constitution and by-laws, and other official publications adopted by the Chapter Board of Directors as minimum standards

**Section VII**    **Affiliation**

The Chapter shall function in affiliation with the Wisconsin Society of Land Surveyors, and shall be governed by the provisions of its Constitution and By-Laws, and other officially adopted standards of conduct and practices. The Chapter shall not adopt provisions in conflict with those of the Wisconsin Society of Land Surveyors. Any donation to the Wisconsin Society of Land Surveyors or Wisconsin Society of Land Surveyors Foundation may be made at the discretion of the Board of Directors

**Section VIII Ethics and Practice**

It is the primary intent of the Chapter to support the highest standards of ethical conduct and professional practices of land surveying by its members, so as to attain the confidence and respect of the public and to attract those aspiring to become a Land Surveyor by personal endeavor. Membership in the Chapter shall be subject to suspension by the Board of Directors for any member who, in the opinion of the Board of Directors or by complaint, has exhibited conduct detrimental to professional image of land surveyors. Any such member shall personally appear upon request before the Board of Directors in closed session to answer for his or her conduct. Failure to appear before the Board of Directors will constitute cause for suspension of membership in the Chapter

**Section IX Chapter Objectives**

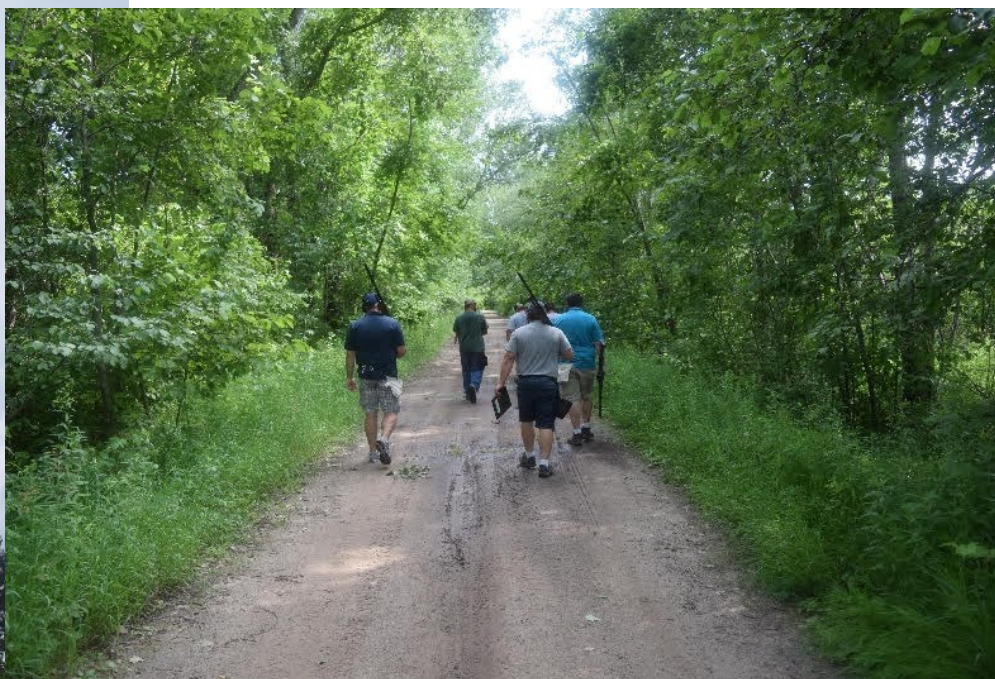
The Board of Directors shall direct the affairs of the Chapter in such a manner as to promote land surveying as a profession, including professionalism among its members and ethical standards of practice, continually supporting both its own stated objectives and those of its parent organization, Wisconsin Society of Land Surveyors

**Section X Membership Responsibility**

Chapter members are expected to be responsible for regular attendance and voting at General Membership meetings. Further support must be shown by prompt payment of dues and service on committees as necessary. Members are expected to act professionally at all times
